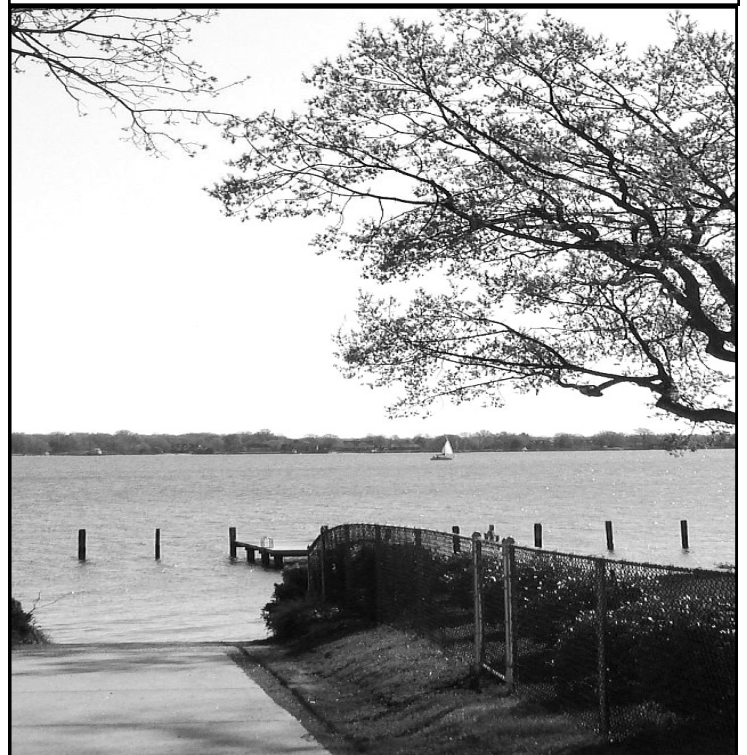

## Security

The days are longer, the sun is brighter and our neighbors, friends and family have taken to the outdoors. But as we enjoy the wonderful weather, keep in mind there have been a series of recent thefts throughout the neighborhood. Remember to lock your doors and shut your garages at the end of the day. If you see any suspicious activities or persons in the community, do not hesitate to call the police.

Another issue of concern is that of loose dogs. Whether in your yard or walking with you, it is law to have your animal contained or leashed. This is for your own protection as well as that of the animal's. We had an incident where someone's dog was attacked by a dog that was in a fenced yard but easily able to get out. The attacking animal injured the leashed dog and was subsequently euthanized. This situation could have been avoided if the dog in the yard had been properly contained.

Another incident involved a person walking with an infant in a stroller and a leashed dog. They passed a yard where the owners were working outside with their loose dogs. These dogs became aggressive with the leashed dog. The stroller was knocked over in the scuffle. Luckily the child wasn't hurt.

If you wish to file a complaint about a loose dog, an affidavit can be filed against the owner. The affidavit can be obtained via animal control (410-222-8900), but please note that it MUST be notarized before it is filed or the complaint will not be investigated.

Despite these recent incidents, Loch Haven is still one of the safest and nicest communities in the county. If you experience or witness a situation that you feel is suspicious or dangerous, do not hesitate to call Anne Arundel County police.

County residents are encouraged to call 911 even for non-emergency issues, but the county police can be reached at 410-222-1960. I would appreciate knowing about any incidents of concern to our neighbors and I can be reached at security@lochhaven.org or at 443-203-6951.

## **Pier** **Ricky Dicken**

Yes, it's the start of another boating season! The Pier is in great shape thanks to all the folks that helped during the work party—what a turnout! As always it's not just about getting the normal maintenance work completed but also getting together with friends and neighbors.

I'm happy to report that there are only 10 names on the waiting list. Depending on the size of the boats on the list, the wait should be relatively short. There are two spaces available on the kayak/canoe racks. If you're interested, give Mike Bryan a call, 410-956-2199.

Boat Safety checks will be offered again this year, thanks to Gary Antonides. The inspections will take place on June 5 at 8:00 a.m. at the pier. Gary has in the past inspected boats on trailers. For information, call Gary at 410-798-7661.

For the 2011 boating season, proof of liability insurance will be required. The minimum limit will be \$100,000. This should not pose a problem. On the 2010 registration form the Pier Committee requested this information and most current slip holders have at least the minimum requirement.

On the boat maintenance front, go through your boat and check the electrical connections. This includes the grounding and bonding of your thru-hull fittings as well as your running gear. These fittings may or may not be bonded. If there are signs of corrosion or rust (green or rust color), take the connection apart and clean and coat the connection with an anti-corrosion product. If your battery charger has any corrosion or rust, get it tested. Discolored wire insulation close to connections is a sign of abnormal heat on the connection. This could lead to equipment malfunctions or even fire. Another byproduct of bad connections are types of stray currents and/or galvanic reactions.

These issues are very hard to detect and in some instances affect other boats on the Pier. If you need any advice, contact a marine electronics specialist. MTS Marine Technical service is such a company, run and owned by a slip holder and neighbor Ryan McQueeney. Ryan can be reached at 410-867-0676.

The fishing tournament raised over \$500 for the Pier. Thanks to all the anglers and to Steve Schad for heading up the event. At the fish fry the following weekend, the fish and other foods were great!

From the Pier Committee: Have a safe boating season and operate your boat responsibly.

This year anyone over 16 years old who is fishing on the Chesapeake Bay must register with NOAA. This is about a five-minute procedure and is fairly painless. You can go to [www.countmyfish.noaa.gov](http://www.countmyfish.noaa.gov) and follow the step-by-step directions. You can also call (888) 674-7411.

Please print out your card and have it with you. I don't know the repercussion if you're stopped and fail to produce a card, but I am sure it is unpleasant.

Everyone fishing with you must bring their cards with them. Think of it as your passport to fish.

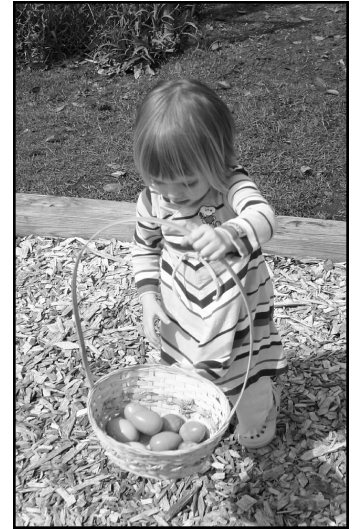

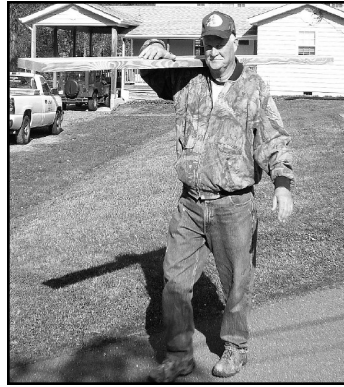
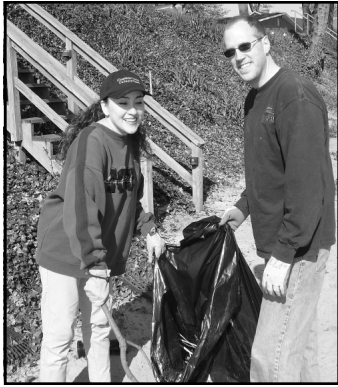
